




Applauding 45 Years of Board Certification

Forty five years ago, the very first Board Certified attorneys in Texas were sworn in for the first specialty areas launched by TBLS — Labor and Employment Law, Criminal Law and Family Law. Today, there are 25 specialty areas for attorneys and 8 specialty areas for paralegals. Out of the 7,300 Board Certified Texas attorneys, several with multiple certifications, there are only 34 that have been with TBLS since the beginning.


We had the chance to hear from a few of these attorneys on what it means to them to be Board Certified for 45 years.
