# **Q&A with New TBLS Board Chair David Dickson**

"Board Certification continues to play an important part in the changing legal industry."

- Q. You've been elected as the new Board Chair of one the largest legal Board Certification programs in the country. How do you feel?
- A. I feel very humbled. This program is important for the public and for attorneys in our state. We're focused on enhancing the quality of legal representation in an increasingly competitive marketplace. I've been involved with this program for more than 30 years and am continually impressed with TBLS members' accomplishments. There are some great attorneys who've served as Board Chair, the last being Hal Moorman.

### Q. What can members expect from TBLS in the coming years?

A. They can expect to see new specializations — beyond the 22 for attorneys and 7 for paralegals that we offer now. For example, we just authorized a new specialization in Construction Law. We're working on several others, such as Property Owners Association Law. Members also can expect TBLS to be constantly reviewing — and revising, when needed — the specialization qualifications that attorneys and paralegals must meet.

#### Q. How has Board Certification impacted your career?

A. It's been hugely beneficial. I became Board Certified in 1983 in all three areas of real estate law — Commercial, Farm & Ranch and Residential. In my dealings with attorneys from all over the nation and internationally, I've found that when you tell them you're a real estate lawyer from Waco, Texas, it doesn't mean a lot to them. But when you tell them you're Board Certified, it really makes a difference in how they see you and your legal abilities. For example, I was recently dealing with an attorney in Vancouver. When he learned that I was Board Certified, he became much more receptive to my advice, and his overall responsiveness improved. This shows the positive impact that Board Certification can have.

# Q. What's one of your proudest achievements of your career?

A. I'm proud to have been elected to the State Bar of Texas Board of Directors. I also served two terms as chair of the Professionalism Committee. I received a Presidential Citation in 2010 for serving as chair and for leading the effort to implement "Transition to Practice" and "After the Bar Exam" programs for new lawyers. And of course, I am proud to be TBLS' new Board Chair.

# Q. How would you describe the current Texas legal industry?

A. The Texas legal industry is in a time of transition. Clients expect a lot of bang for their buck, and lawyers have to adapt to meet new client expectations. Board Certification continues to play an important part in the changing legal industry.
